Due to the lack of what I feel is support and help from the Waterford office, I contacted the head office this morning.

During a call with Sinead, I asked her to stop cutting me off while I was speaking, and she hung up. When I called back, I was given a number for customer complaints, which turned out to be the Smithfield office in Dublin. This shows a total lack of respect and care for a client.

This incident occurred after I had already received a letter from the Legal Aid Board citing a lack of evidence for my case. This directly contradicts the initial meeting with your solicitor, who described my case as "massive." I have since spoken to several other professionals, including solicitors, who all agree that I have a

strong case.

I feel as if I'm just being blown off by the State. As a State body, is it reasonable for me to assume that you will do everything possible not to take action against your employer? Because that is how this looks. I also wish to make it clear that if these issues are not properly addressed, my intention is to respectfully present myself before an honourable judge of the high court and explain my situation directly. This is not done lightly — I genuinely believe my circumstances are a matter of life and death, and I have exhausted all other avenues seeking help and justice.
