I am writing to formally demand urgent action regarding the repeated refusal of the Legal Aid Board to provide me with legal assistance, despite the severity of my circumstances.

I met with a solicitor at your office and disclosed the childhood sexual abuse I suffered, the trauma of adoption, and the failure of my father to support me when he became aware. I was explicitly told I had a massive case worthy of your support.

Yet, only five days later, I received a letter stating there was a lack of evidence and that no assistance would be provided.

Subsequently, after being assaulted by a registered paedophile in Maguire House — an assault caught on CCTV and currently under Garda prosecution — I sought your help again. Despite this, your office again refused to provide support.

To compound matters, I have now discovered that a registered sex offender recently lived in my current residence without my knowledge, creating an unsafe and intolerable living environment.

This pattern of neglect and refusal is unacceptable. I demand the Legal Aid Board immediately reconsiders my case, provides the necessary legal assistance, and supports me in pursuing justice and safety.

Failure to act will leave me no choice but to escalate this matter publicly and through non-violent civil disobedience to bring attention to the systemic failure to protect vulnerable survivors.

I expect a prompt and meaningful response.


