Subject: Request for Internal Review of Complaint - Ref 4779999 (Law Centre 4587315)

Dear Review Officer,

I am requesting an internal review of the handling of my complaint, under the Legal Aid Board's complaints procedure.

I received the decision from Managing Solicitor Aidan Lynch dated [insert date], which did not uphold my complaint. I request a review because the investigation and decision were incomplete and failed to address the core issues I raised.

1. Ignored the core matter of my complaint

My complaint clearly explained that I was seeking legal aid to hold Waterford County Council accountable for placing me in accommodation with known paedophiles, an experience that caused me serious harm.

The complaint decision does not mention this at all, even though it was the central reason for my application and complaint.

2. Ignored misleading communication

I was told "yes" on two separate occasions regarding my application(s), and later received a letter of refusal

The complaint decision does not address or explain this change, which is a clear procedural failure.

3. Incomplete and unsatisfactory investigation

The decision simply states that Ms. Phelan acted "professionally," without addressing the specific harms, miscommunication, and mishandling I raised.


By failing to acknowledge or examine the central issues, the decision is defective and unfair.

I am therefore requesting that the Review Officer conduct a full and proper review of the handling of my complaint, ensuring that all the facts and concerns I raised are actually addressed.
