

On 3 September 2025 at approximately 9:30 PM, the landlady's cleaning lady entered the property without providing the required 24-hour written notice. I told her I did not want her in the house and asked her to leave. This is another breach of my right to quiet and peaceful enjoyment of the property.

It is quite disturbing that someone can just walk in my door at that time of night.

I have attached a photograph I took at the time as evidence of this unauthorized entry, which is date stamped at approximately 9:30 PM.
